## Unusual AWS Command for a User

Security: Cloudtrail - Looks for AWS API calls that, while not inherently suspicious or abnormal, are sourcing from a user context that does not normally call the method. This can be the result of compromised credentials or keys as someone uses a valid account to persist, move laterally, or exfil data.


